Ursula von der Leyen: la presidenta de la Comisión Europea que ha captado la atención de los votantes

A medida que los 400 millones de ciudadanos de la UE se preparan para votar en las elecciones europeas de junio, una nueva encuesta muestra que es Ursula von der Leyen quien ha llamado la atención de los votantes como ningún otro jefe de la UE antes que ella.
